簡史 History

本會成立於民國六十年正月，當時定名「台北縣護士公會」，由衛生局第五課吳課長蜜蓮女士擔任首屆理事長，民國七十四年七月為符合護理人員管理規則之需要，改名為「台北縣護理師護士公會」；民國100年配合台北縣升格為新北市，更名為「新北市護理師護士公會」。

本會會員人數截至106年12月為止共18,210人，其中服務醫院會員數10,621人佔57.6%，診所會員數3,395人佔19.4%，長期照護機構會員2,423人佔13.0%，學校護士589人佔3.5%，衛生局所護理會員數369人佔2.1%，工廠護士158人佔0.8%，護理學校老師161人佔0.9%，其他如個人會員有494人佔2.7 %。

The New Taipei City Nurses' Association (NTCNA) was founded in January 1971 and reincorporated in July 1985 in accordance with the national Regulations Governing Nursing Personnel.

The NTCNA had a membership of 18,210 at the close of 2017. Of these, 10,621 (57.6%) worked for hospitals, 3,395 (19.4%) worked for medical clinics, 2,423 (13.0%) worked for long-term care institutions, 589 (3.5%) worked for schools, 369 (2.1%) worked for local health bureaus, and 158 (0.8%) worked for manufacturers. Additionally, 161 (0.9%) held positions as nursing educators at institutes of higher learning and 494 (2.7%) held non-affiliated or individual memberships.

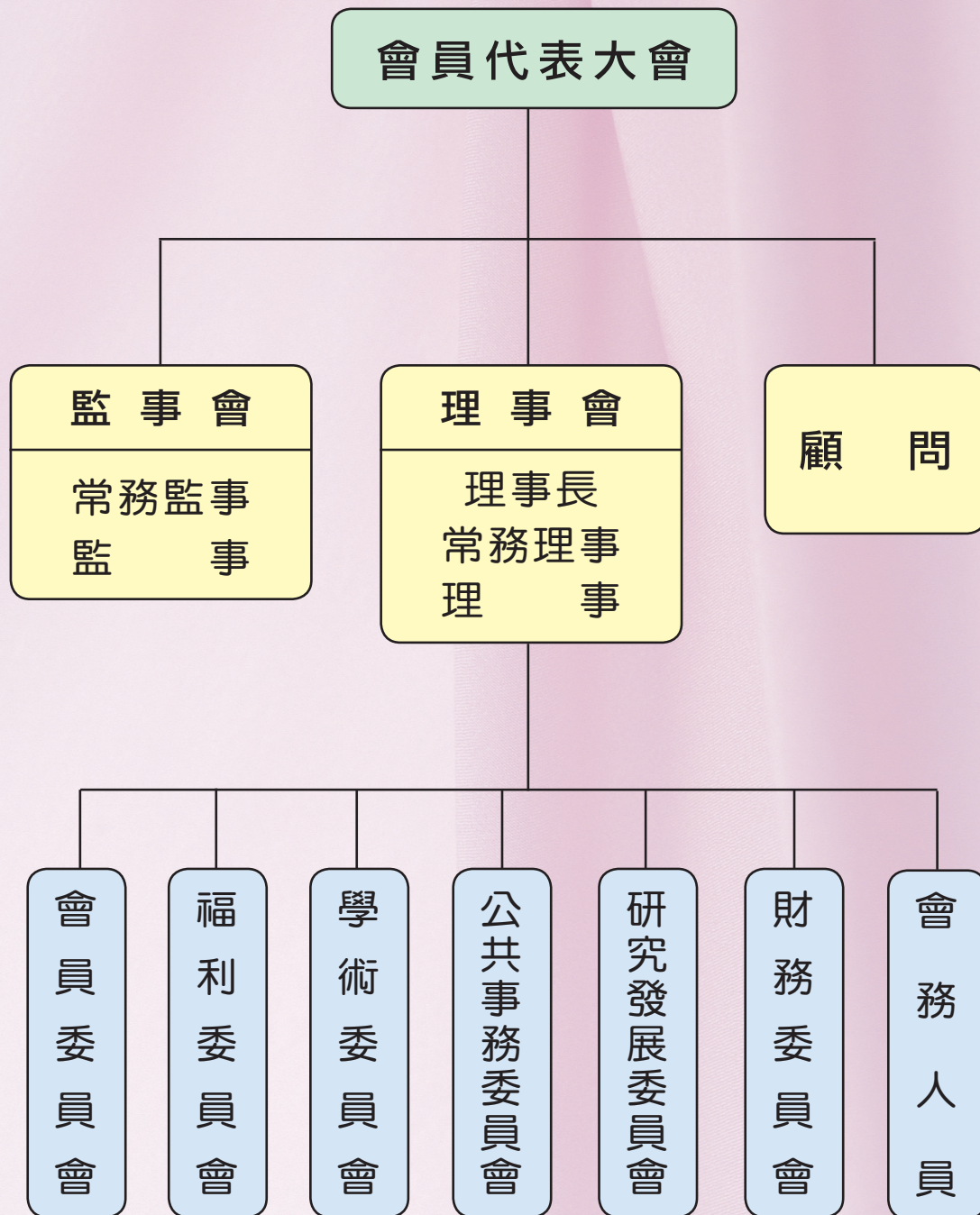

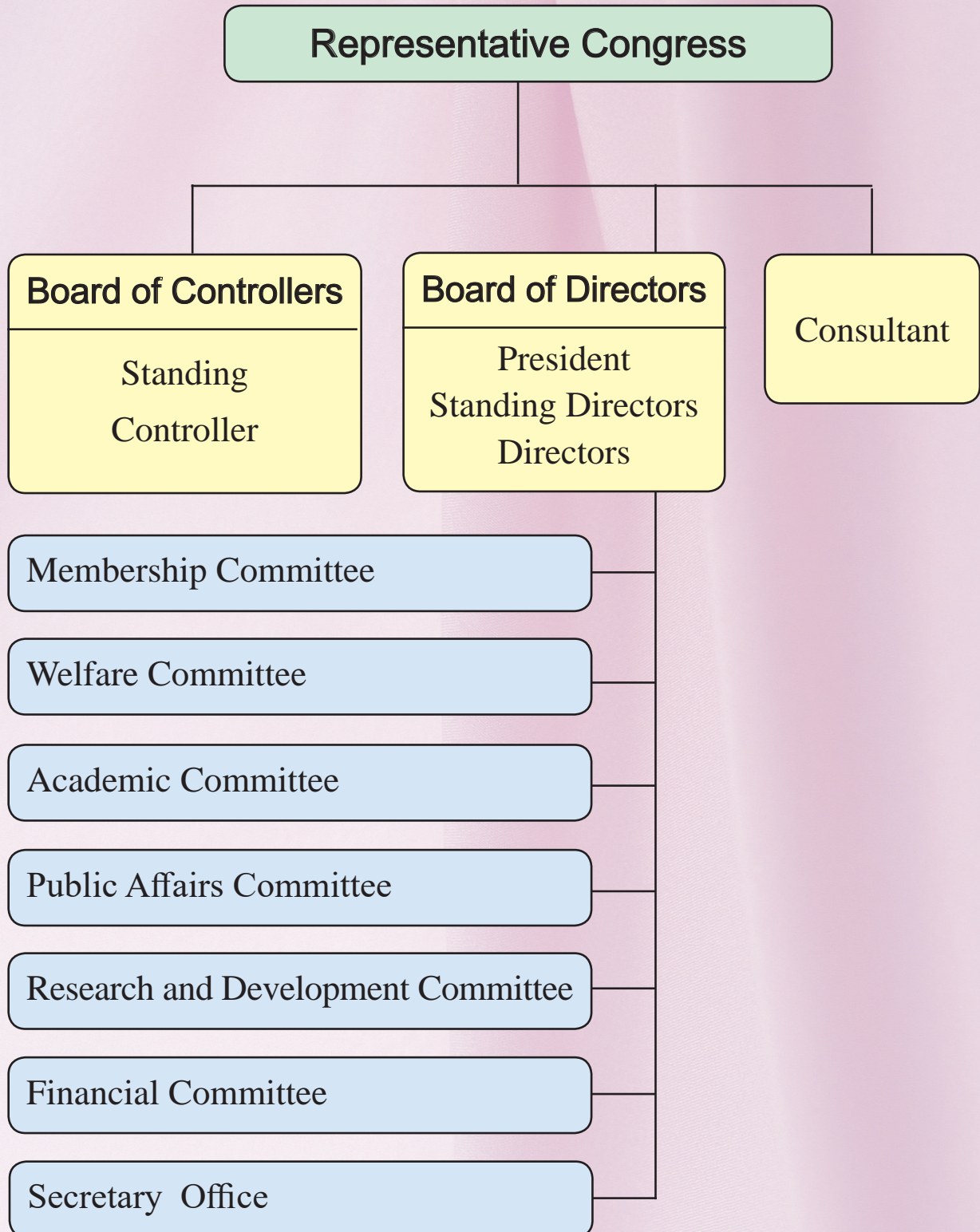

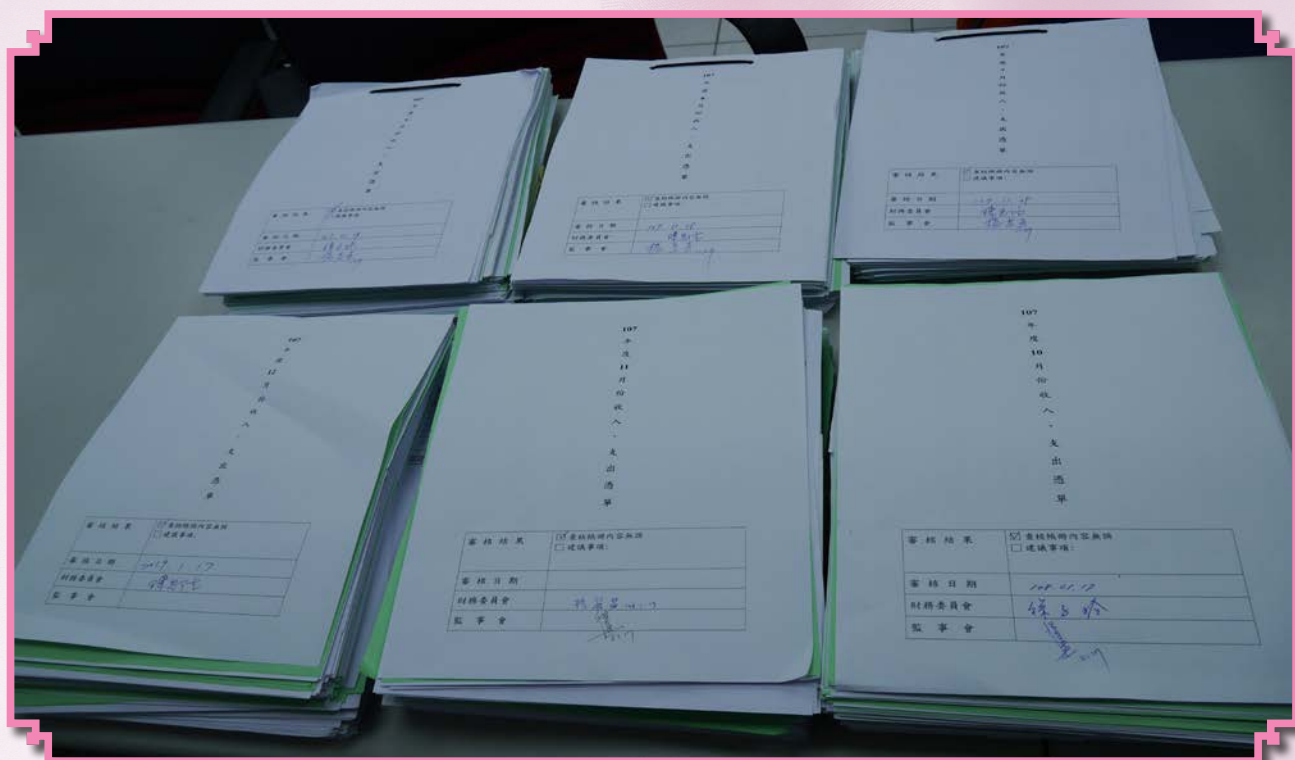
